

CONSTITUTION.

Art. 1. NAME.

The name of this School shall be the ~~Waddy~~ Utica Ave. Pentecostal Tabernacle Sunday School of Brooklyn N.Y.

Art. 2. Object.

The object of this school shall be the study of the word, the conversion of sinners and the sanctification of believers.

Art. 3. Officers.

The officers of the school shall consist of two Superintendents, (male and female), an assistant Superintendant, a Secretary, and assistant Secretary, a Treasurer, a Librarian, an Assistant Librarian, and an Organist.

Art. 4. Election of Officers and Teachers.

The officers and teachers shall be elected annually by ballot, at the regular meeting in April.

Sec. 1.

The election of Superintendant and Treasurer shall be approved by the Official Board of the Church.

Art. 5. Teachers.

No person shall be elected teacher in the school who has not been thoroughly converted, and who is not going on to Perfection.

Nor shall any person teach who holds doctrinal views contrary to the Articles of Faith in our Church.

Sec. 1. No person should be elected permanent teacher who is not, and who does not intend to become a member of the church.

Sec. 2. Duties of teachers shall be to be punctual in attendance, to visit their scholars in their homes, to assist the officers to enforce the rules of the school. To notify the Superintendant in case of necessary absence.

Art. 5. Sec. 1. The duties of the Superintendants shall be to have general charge in direction of the Sunday School with power to make and enforce such rules and regulations as in their judgment shall be necessary to preserve order and discipline in the school.

Sec. 2. The duties of the Assistant Superintendant shall be to assist the Superintendants in the discharge of their duties, and in the absence of the male Superintendant to occupy his place.

Sec. 3. The duty of the Secretary shall be to keep carefully and in good order the register of the school, and record all its transactions and discharge all other duties pertaining to this office.

Sec. 4. Treas. The Treasurer shall receive all monies belonging to the school, keep a correct account of the same, and disburse only by order of the board.

6.5. Librarians The Librarians shall have charge of the library, and see that all books are neatly and properly covered, be at all times able to state in whose possession any book absent from the library may be; punctual at their post, prompt in distribution, and, so far as consistent with the rules, endeavor to accommodate each applicant and to see that all literature has been properly examined and approved by the committee on literature before distributing the same.

Sec.6. Organist. It shall be the duty of the organist to be promptly in their place at the opening of the school, and to study ways and means for improving the music of the school..

Art.7. Scholars. Sec.1. All persons desirous of studying the Holy Scriptures, and receiving religious instruction, who have attended four consecutive Sabbaths, unless properly excused, and have had their names registered by the Secretary, shall be considered scholars, and shall be entitled to all the privileges accorded to a member of the school.

Art.8. Meetings. Sec.1. The Annual meeting shall be held on the evening of the first Monday in April at eight o'clock.

Sec.2. There shall be a business meeting held on the evening of the first Monday of each month at eight o'clock.

SEC.3. Special meetings may be called by the Superintendent, and at the request of at least five members. Notice having been given, and the object stated at the session of the school.

Art.9.S.S.Board. The school shall be under the supervision of a Sunday School Board, consisting of the superintendents, assistant Superintendent, the Secretary, Assistant Secretary, the Treasurer, the Librarians, the organist, and the teachers of the school.

Art. 10.Quorum. Five members of the Board shall constitute a quorum for the transaction of business.

Art.11. Standing Committee. Committee on literature - It shall be the duty of this Committee to recommend suitable literature for the use of the school, and to examine all literature before being placed in library for circulation.

Sec.2. Committee on Benevolence. It shall be the duty of this committee to assist in providing necessary clothing, etc., for such members of the school and others as may require assistance.

Art 12. Missionary Sunday. The last Sunday in every quarter will be known as "our missionary Sunday." and the collection for that day, shall be used for foreign work. After the opening exercises and about fifteen minutes.

on the lessson the remainder of t e session, shall be devoted to missionary exercises or prayer meeting.

Art.13. School Session. The school shall be opened each sab bath at at 2.45. oclock.P.M.And closed at the 3.55.

Art.14. Amendments.-- Notice to amend or speal this constitution must be submitteed in writing at a regular meeting of the board at least one month previous to any action being taken on the same. A two thirds of the entire board of officers and teachers present at a regular meeting shall be necessary to secure such amendment or repeal.
